What is PSI?

This service carried out for governments combines confirmation of the buyer's specifications, and quantity and value controls of imports/exports. It is done in compliance with WTO (World Trade Organization) requirements. In carrying out pre-shipment inspection of goods on behalf of Customs authorities, Bureau Veritas helps international trade operators to comply fully with current legislation. This improves their business efficiency and eliminates risk wherever possible.

OUR APPROACH

1. Import registration in the importing country

- The importer lodges a pro-forma invoice with the Bureau Veritas office.
- Which passes it to the appropriate Bureau Veritas office in the country of export.

2. Intervention in the supplier country

- The Bureau Veritas office in the country of export examines the documents.
- Conducts a physical inspection of the goods for export.
- Ensures that their description matches the information on the Preshipment Inspection order and pro-forma invoice.

On the basis of inspection reports, the Bureau Veritas office in the country of export:

- Assigns the correct customs classification code to the goods.
- Makes a final price analysis.
- Calculates the value for customs duty purposes in line with Customs regulations in the importing country. If quantity, specifications of goods and price are right, or have been corrected to remove any discrepancies, the Bureau Veritas office issues a Clean Report of Findings (CRF).

3. Customs clearance in the importing country

- The local Bureau Veritas office receives CRF data.
- Delivers the printed documents to the importer to be presented to the authorities.

Detailed information on procedures in force in countries currently under contract is available from our local Bureau Veritas offices.



FAQ

Are all goods subject to inspection?

No, some goods may be prohibited and others are exempted depending on the destination country (see corresponding datasheet on Web site).

What is the minimum value subject to inspection?

The minimum value is designated by the client country. If goods are covered by several commercial invoices, all issued by the same exporter, arriving by the same means of transportation, consigned to the same importer and having a combined value above the established minimum, they will be subject to Pre-shipment Inspection.

Should the goods be packed prior to inspection?

Goods should be presented along with the packaging to be used. However, if the packaging does not allow the inspector to correctly identify the items, it would have to be reviewed and repacked under inspection control.

Who pays for the inspection?

It could be the government, the importer or the exporter, depending on the country (see corresponding datasheet on Webs site).
