## VERIFICATION OF CONFORMITY (VOC)

Consumer and environmental protection by implementation of national/international standards.

### BUSINESS CHALLENGE

Governments today give high priority to promoting international trade while protecting consumer health, safety and the environment. Most national standard organizations, acting within a legislative framework, call for the intervention of independent third-party companies as a way to maintain full control on goods entering the domestic market.

### SOLUTION

#### What is VOC?

The Verification of Conformity service involves checking conformity of goods according to national standards or an international equivalent.

At the same time it encourages importers and exporters to understand the need for compliance and its benefits. For ad hoc or first time shipments, importers go through the basic shipment process: documentary evidence is required to prove compliance with the required standards, or the goods can be tested in an approved laboratory.

The shipment will be subjected to physical verification to ensure that the documents match the products and that no deviations are found. Regular shipments can be treated under registration or licensing.

#### What are the key benefits?

- Protect consumers against dangerous, sub-standard or counterfeit products.
- Provide a guarantee to the buyer that the goods ordered are those shipped.
- Ease trade operations by recognizing existing conformity proof to avoid unnecessary additional testing.
- Conform with recommendations of the World Trade Organization "Technical Barriers to Trade" Agreement.
- Protect domestic industry from unfair competition of poor quality imports.
- Improve the environment.
- Enhance the quality of exports.

## OUR APPROACH

The usual steps of VOC are as follows:

### 1- Import registration in the importing country

An Inspection Order (IO) containing details of the intended importation is submitted by the importer to the Bureau Veritas local office, or by the exporter to the Bureau Veritas office in the country of export for each transaction subject to the program. The IO data is sent electronically to the appropriate Bureau Veritas office.

### 2- Intervention in the manufacturing country

• Contact with the Exporter

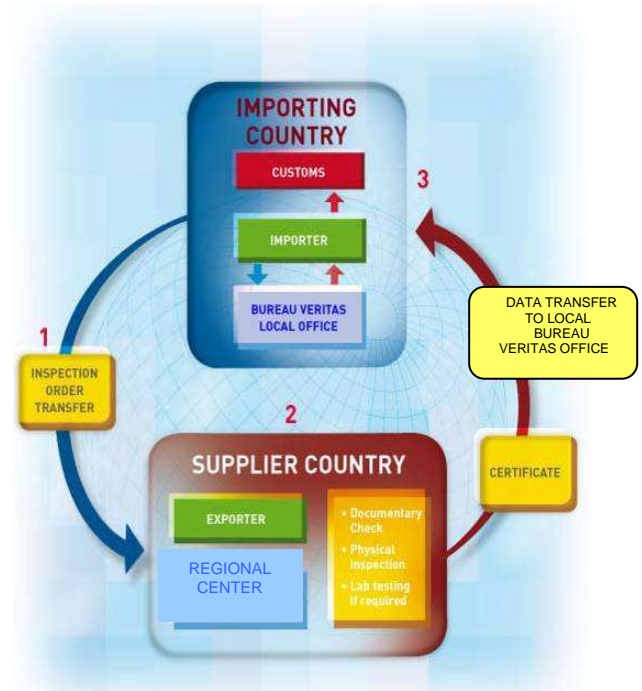
The Bureau Veritas office in the country of export sends a notice to the seller to ask when and where the goods will be ready for inspection and to request the following information:

- 1- Verification of conformity to standards of the importing country
  - checking of the existing certificates and testing/analysis reports
  - testing, if necessary
- 2- Inspection of exported goods:
  - visual and documentary checking
- 3- Final review

### 3- Customs clearance in the importing country

Bureau Veritas local office delivers the Certificate of Compliance to the importer. The certificate is secured (protected against copy and falsification) and identifies the goods and the applicable standard. It is required for customs clearance.

Detailed information on procedures in force in countries currently under contract is available from our local Bureau Veritas offices.



## FAQ

### Who pays for the inspection?

It could be the government, importer or exporter depending on the destination country (see corresponding datasheet on Web site).

### Are all goods subject to inspection?

No, some goods may be prohibited and others can be exempted, depending on the destination country (see corresponding datasheet on Web site).

### What is the difference with product certification?

VOC is limited to verification of conformity of goods per shipment to a specified country. Product certification usually applies to the product without any geographical limitation and is based on testing and factory audits.

### What is the difference between PSI and VOC?

• PSI (Preshipment Inspection) is the assessment of quantity, price verification and customs classification prior to the shipment of goods. It provides advice to the customs in order they may collect the correct revenue.

• VOC (Verification of Conformity) checks conformity of goods to relevant national or international standard, taking into account the local specificities (language...).
